BUDGET AMENDMENT

This budget amendment is to account for previous approved bargaining agreements and a change in the non-represented healthcare and dental spouse/family share to conform with the bargaining agreements.



2024 BUDGET AMENDMENTS/ADJUSTMENTS

Teamsters Bargaining Unit

\$135,300 <u>adjustment</u>. City Council approved the Teamsters Collective bargaining agreement on January 16, 2024.

Oak Harbor Police Association Bargaining Unit \$263,000 <u>adjustment</u>. City Council approved the Oak Harbor Police Association (OHPA) Commissioned and Non-Commissioned bargaining agreements on February 5, 2024.



2024 BUDGET AMENDMENTS/ADJUSTMENTS

Interntl. Association of Firefighters Bargaining Unit \$90,200 adjustment, \$24,600 amendment. City Council approved the International Association of Firefighters (IAFF) bargaining agreement on April 2, 2024.

Non-Represented Employees

\$48,400 <u>adjustment</u>. Proposal to adjust the Employer/Employee Medical & Dental Family and Spouse cost share from the current 80%/20% to 90%/10% to match what has been included in the previously approved bargaining agreements.
